PRIVACY POLICY AND NOTICE OF COLLECTION AND USE OF YOUR PERSONAL INFORMATION

The May Court Club is aware of and recognizes its responsibilities under applicable protection of privacy legislation.

Collection of Personal Information

The May Court Club collects your personal information such as your name, postal and e-mail addresses, telephone number, fax number and your photo (one you have provided to us or one taken at a Club event).

Purpose of collecting your personal information

The collection of your personal information by the Club is for the following purposes:

1. **to** notify you of Club events;
2. **to** send you newsletters;
3. **to** provide an annual report including your name only;
4. **to** provide a membership roster to members only, including your name and contact information to facilitate communication within the Club;
5. **to** list your name on The May Court Club of Oakville web site if you become a member of the Board, Standing Committee, Special Committee, Service Program Convener, or Social Group Convener;
6. **to** record your volunteer activities;
7. **to** promote the Club's activities;
8. **to** process tax receipts; and
9. **to** provide the government with any required information.

The Club does not use your personal information for any other purpose other than as listed above and does not sell, disseminate or disclose your personal information to organizations outside the Club.

Protection of privacy

In its office practices, the Club safeguards your personal information from unauthorized access, disclosure, copying, use or modification and will continue to do so.

The Roster of members is intended for use by May Court members for information purposes only. Any other use, for solicitation or otherwise, is strictly forbidden. Members shall use discretion in the disposal of Club publications, correspondence and other documents, especially those of a confidential nature.

Consent

By choosing to be a member of the Club and by providing us with your personal information, you are consenting to its collection and its use in accordance with this policy and notice or as outlined at the time you are asked to provide any personal information. In addition, during some Club events, photographs, video/audio recordings of Club members taking part in the event may be taken. By participating in the event, you consent to being photographed, video/audio recorded and to the Club's use of the photographs and/or recordings in any format or medium (including the Club's website and on social media) to promote Club activities and events.
